**Budget Related Motions of Council Date** BIRT AUSU Council allocate an addition \$849 to the 2015/2016 budget account 5/10/2016 Smart Draw to cover an unexpected overage due to currency conversion. BIRT Council approve budget overage of up to \$2000 to "Telephone and Internet" to accommodate the unexpected replacement of AUSU Office 4/1/2016 telecommunications. Email Vote Ratification: BIRT AUSU approves a transfer of \$3000 from the budget for Staff Salaries (GL 5210) to the budget for Other Staffing (GL 5318) to 3/10/2016 accommodate the contracting of TPD in hiring a new part time administrative assistant. (S. Wasylyshyn / L. Zhu, Carried 7/0) Email Vote Ratification: BIRT AUSU council approve the expense of \$3474.40 to Mailchimp.com for the purchase of 2 million email credits (B. Simmons/L. Zhu; 1/14/2016 Carried 9/0). BIRT AUSU renew the Lynda.com account for a three year subscription for 1000 12/10/2015 users at a cost of US \$22,200 per year/CA \$29,400 +-. BIRT that any funds remaining in the AUSU Health and Dental plan account after 10/26/2015 termination of the plan be allocated to the AUSU Awards Committee for use in a onetime health care bursary with preference for recipients given to those who participated in the AUSU Health and Dental Plan. 10/13/2015 BIRT AUSU accept the presented budget documents and 2015/2016 budget.
